We're happy to confirm that you are in current RCN Nurse Full membership. You joined us on 09-Jul-2019. Benefits are subject to you staying in membership.

As an RCN member your benefits and services include:

All health professionals need to confirm that they have indemnity cover in place when they register with the NMC. As a member, in most circumstance, indemnity cover is provided either by your employer or by the RCN. In certain limited circumstances you'll need to purchase cover for yourself or your employees.

If you're genuinely self-employed your cover may be provided by the RCN. However there are exceptions and exclusions so you must read the document to be sure of your position. Details of the scheme are available online at

https://www.rcn.org.uk/get-help/indemnity-scheme. RCN advisers are available to help with enquiries and can be called on 0345 772 6100. The RCN scheme also covers voluntary and Good Samaritan work.

Under the RCN scheme, we assess on each individual claim that is referred to us whether the member was complying with the scheme at the time that the incident occurred, to check that no exclusions apply. Accordingly, we cannot guarantee at this point in time whether you will be complying with the scheme at some point in the future. We would ask you to check our scheme document carefully to ensure whether conditions or exclusions currently apply to your practice. Should your practice change

after the date of this letter, which you believe might take you outside of the scheme, please ensure that you carefully re-read the terms of our scheme document.

Indemnity cover is the term used to describe the financial backing available to cover the costs of a clinical negligence claim against you. It's completely separate from the legal and trade union support available to all members, whether or not they are covered by the indemnity scheme. If you have a dispute with your employer, are facing a disciplinary process or a referral to the Nursing and Midwifery Council, the full services of the RCN are available to you as a member.
